- 2. Amendment / Advising of amendment... EUR 50
- 3. Items returned unpaid or unaccepted... EUR 25
- 4. Releasing of documents "free of payment"... EUR 50
- 5. Payment ... 0.25% min EUR 25

## B. Documentary collection

- 1. Advising / remittance of documents for acceptance/payment... 0.25% min EUR 50
- 2. Amendment / Advising of amendment... EUR 50
- 3. Items returned unpaid or unaccepted... EUR 50
- 4. Releasing of documents "free of payment"... EUR 50
- 5. Payment... 0.25% min EUR 25

## C. Documentary Letter of Credit

- 1. Advising ... 0.20% min EUR 75
- 2. Pre-advising (in addition to advising) ... EUR 75
- 3. Confirmation (per quarter or part thereof) ... negotiable but not less than EUR 100
- 4. Issuing / amount increase / validity extension (per quarter or part thereof) ... negotiable but not less than EUR 100
- 5. Deferred payment/Acceptance (per quarter or part thereof)... negotiable but not less than EUR 100
- 6. Negotiation/Handling/Payment... 0.25% min 75 EUR
- 7. Other Amendments / advising other amendments... EUR 75
- 8. Transfer... 0.20% min EUR 150
- 9. Assignment of proceeds... 0.25% min EUR 75
- 10. Discrepancy fees (per discrepancy)... EUR 25
- 11. Cancelation/ Non-utilization... EUR 75

## D. Bank Letter of Guarantee

\* In case of issuance of guarantee based on a counter/guarantee, commission is payable for the validity period of the counter/guarantee.

## E. Miscellaneous Services

- 2. Information on bank's customers... EUR 50 (plus VAT)
- 3. Accounting information for audit purposes... EUR 50 (plus VAT)
- 4. Investigation of transactions... EUR 30
- 5. Transmission of SWIFT messages upon financial institutions request... EUR 10
- 6. Incoming payments from other banks (option OUR)... 0.1% min EUR 2 max EUR 100.
